
# Horizon 2020 – Societal Challenge 7 "Secure Societies"

# **Social Sciences and Humanities**

=> Cross cutting tool to improve the assessment and response to complex societal issues at the centre of security challenges





# **Expertise of the SSH needed for**

- Understanding causes and societal roots of security threats
- Understanding causes and roots of human behaviour (perception of security/in-security, societal resilience, culture of risk)
- Understanding interactions among humans, and between humans and technologies or environment
- Developing/applying innovative socially compatible technologies
- Integrating society concerns and citizens' rights (least intrusive solutions, ethical framework, legal compliance, transparency ...)

- All H2020 grant applications considered for funding undergo an ethics review based on:
  - an ethics self-assessment
  - an ethics review by independent ethics experts
- All ethics requirements set by those experts need to be fully implemented by the project
- The identified ethical aspects must also be considered during the lifecycle of projects
- In projects raising serious ethical concerns, ethical checks and audits are executed during the course of the project.

#### Does your research have negative impact on society?


Ex. If implemented, could the research impact disproportionately upon specific groups or discriminate?
